DESCRIPTION OF DUTIES: THIS POSITION IS ASSIGNED TO BULLOCH, SCREVEN, AND JENKINS. (APPLICANT MUST RESIDE IN ONE OF THESE COUNTIES OR BE WILLING TO RELOCATE). Inspects and investigates food and dairy facilities for compliance with applicable health and sanitation laws and regulations. Duties will involve collecting food samples for laboratory analysis, verifying accuracy of scales, candling eggs, checking refrigeration equipment for proper operation, proper product packaging and labeling, observation of food facility employees, proper equipment cleaning procedures and proper handling of insecticides and sanitizing chemicals.

MINIMUM QUALIFICATIONS: Completion of a bachelor's degree in agronomy, animal science, biology, chemistry or a related area OR Certification as a registered sanitarian or environmental health specialist.
